**O R D E R**

The Public Authority is represented by Sri Manoj Kr. Barman, SPIO/Extension Officer (F), Pub- Nalbari Development Block and Sri Binoy Goswami, SPIO/Secretary, 10 No. Dakshin Bahjani Gaon Panchayat. A Written Statement dated 19.04.2016 has been received from SPIO/E.O. (F), Pub-Nalbari Development Block.

Appellant present. Heard the Appellant. He has reiterated that he was not satisfied with the information that was supplied to him by the concerned GP.

Perused the aforementioned W/S. Through the W/S, copies of the communication made in respect of the RTI Application including order of the First Appellate Authority have been enclosed.

Heard the SPIOs. It has been submitted that the information sought for by the Applicant/Appellant had already been furnished.

Perused the case record. It is seen that the First Appellate Authority had issued an order dated 09.12.2014 that the GP Secretary will furnish the unedited and non-highlighted documents/information to the Petitioner on or before 12/12/2014. However, the Appellant had not been furnished with information he had sought for. Thereafter, the Appellant had filed his Second Appeal dated 22.12.2014 before the Commission on non-compliance of the aforementioned First Appellate Authority's order.

In view of the facts brought out above, the Commission hereby orders that the Appellant shall write to the SPIO, office of the BDO, Pub-Nalbari Development Block indicating the anomalies he has noticed in the documents already supplied to him within 10 days of receipt of this order, and that the SPIO, office of the BDO, Pub-Nalbari Development Block shall, with the help of Secretary of the GP, reconcile the anomalies between the statement/list supplied to the Appellant and provide a reconciled statement of IAY beneficiaries duly certified within a period of 10 days of receipt of the aforementioned details from Appellant.

With this, the Second Appeal Petition is disposed of.
