<u>O R D E R</u> 10.5.2016

The petitioner Shri Kandarpa Das is absent without any information. The Public Authority is represented by (1) Md.Sah Alam, Executive Engineer, PWD, Bongaigaon Rural Road Division, and (2) Shri Biswadev goswami, PIO & Asstt. Executive Engineer, PWD, Bongaigaon Rural Road Division. The Second Appeal petition dtd 2.12.13 is taken up for consideration ex-parte in absence of the petitioner.

From perusal of the case records it is seen that the petitioner Shri Kandarpa Das filed an RTI petition dtd 20.8.13 seeking information on 10 different points about construction of roads from NH-31 Patiladoha to Kawadi under PMGSY in the year 2007-08. It is seen that vide letter dtd 9.9.13 the Executive engineer, PWD, Bongaigaon Rural Road division furnished information to the petitioner. Thereafter, the petitioner filed his First Appeal Petition dtd 9.10.13 on the grounds of non-receipt of relevant reply, non-receipt of certified true documents asked for and non-receipt of certified copies of all the extension letters. The Second Appeal petition dtd 2.12.13 is based on the same grounds.

The Executive Engineer, PWD, Bongaigaon Rural Road Division has made a written submission dtd 9.5.16 enclosing copies of all the information already furnished to the petitioner. The Executive engineer further deposed that in response to point number 5 of his (petitioner) RTI petition, the office of the Chief engineer, PWD (Roads) has separately furnished copy of sanction letter from NRRDA.

In view of the above, it appears that all the information sought for by the petitioner have been duly addressed. In absence of the petitioner it could not be ascertained, if he needs further clarification. However, if he needs any further clarification, he is directed to approach the PIO in the office of the Executive

engineer, PWD, Rural Road Division, Bongaigaon during office hours on any working day within 15 days from the date of receipt of this order.

With the above order, the Second Appeal petition dtd 2.12.13 is disposed of.
