**O R D E R**

30.5.2016

The Public Authority is represented by Shri Pradyut Bujarbaruah, MD, APDCL, Bijulee Bhawan, Guwahati-1. The petitioner Shri Ranjit Shekhar Mooshahary has sent a message communicating his readiness to be present in today's hearing. However, this Commission informed him that his appearance in today's hearing may not be necessary and that if further hearing by this Commission is required, he will be informed. Accordingly the complaint petition dtd 27.4.16 is taken up for hearing ex-parte.

The MD, APDCL Shri P. Bujarbaruah is present today. He submitted a written statement dtd 30.5.16. In his written submission he has stated that names of the SPIOs of APDCL exist in the website and can be viewed in the official website of APDCL. However, it was found that the APDCL issued an office order dtd 26.6.2015 whereby Shri Pijush Kanti Shome, DGM, O/O CGM(D), APDCL, Lower Assam Region, Bijulee Bhawan, Paltanbazar, Guwahati- 781 001 was listed as one of the SPIOs under the APDCL. In course of today's hearing it transpired that subsequently, in the beginning of 2016 another officer of APDCL, Shri Prakash Dutta was also notified as SPIO for the office of the Managing Director, APDCL. This Commission could not find the name and designation of Shri Prakash Dutta in the official website [www.apdcl.gov.in](http://www.apdcl.gov.in) of APDCL.

This Commission, therefore, directs the Managing Director, APDCL to correct and update their website immediately with compliance report to be submitted to this Commission within 15 days from the date of receipt of this order.

The present MD, APDCL has enclosed in his written submission, a copy of the letter dtd 3.5.16 addressed to Shri R.S. Mooshahary, IPS (Retd), 182, Nandanam, Bishnu Rabha Path, Beltola, Guwhati- 781 028, whereby the applicant was informed about the action taken so far by the APDCL on the RTI petition dtd 27.4.16. However, it is seen that the action taken so far requires more clarity.

This Commission, therefore, directs the SPIO of the office of the MD, APDCL to inform the petitioner about the concrete action plan that they propose to execute as per procedure along with a concrete timeline within 15 days from the date of receipt of this order.

With the above order, the petition dtd 27.4.16 is disposed of.
