O R D E R 26.05.2016

The Appellant present.

The SPIO/Secretary, Gamariguri S.S. Ltd., Golaghat who was notified in today's hearing is absent without information.

Heard the Appellant. He submitted that he has not received the information he had sought for inspite of the order dated 21.10.2014 issued by Assistant Registrar, Co-operative Societies, Golaghat directing the Secretary of the said S.S. Ltd. to provide information in response to his First Appeal

Perused the case record. It is seen that the information sought for from the said S.S. Ltd. pertains to Public Distribution System, a function the co-operative society performs as an agent of Food, Civil Supplies & Consumer Affairs Department. The Application for information had been made to the Secretary of Gamariguri S.S. Ltd. and First Appeal with the Assistant Registrar, Co-operative Societies, Golaghat. As the Secretaries of Co-operative societies does not constitute a Public Authority under Section 2 (H) of the RTI Act, 2005, it would be more appropriate for the F.C.S. & C.A. authorities in the district to act as Public Authority in the instant case and for such authority to procure information from the co-operative societies such information as can be accessed under any relevant laws they administer.

In view of the facts brought out above, the Commission hereby orders as follows -

- 1. The Superintendant, F.C.S. & C.A., Golaghat being the appropriate SPIO shall procure such information as can be accessed under any relevant law and provide the same to the Applicant, free of cost, within a period of 21 days of receipt of this order.
- Should the Applicant not receive the information in accordance with this order within the stipulated time, he shall be at liberty to file a fresh First Appeal before the Dy. Director, F.C.S. & C.A., Golaghat as First Appellate Authority, and the latter shall dispose of the said Appeal in accordance with the provisions in this behalf in the Act.

Send a copy of the RTI Application dated 23.07.2014 to the SPIO/Superintendant, F.C.S. & C.A., Golaghat.

With this, the Second Appeal is disposed of.
