**O R D E R**

The Appellant present.

The SPIO absent. He has however sent a Written Statement dated 25.05.2016 which is taken on the case record.

Perused the W/S. It has been submitted that the RTI Application dated 5.12.2013 did not bear the signature of the Applicant. Thereafter, a reminder dated 19.05.2014 was received from the Applicant. It is seen that there are anomalies in the dates and chronology of correspondences mentioned in the W/S. However, it has been submitted that information had been provided to the Applicant/Appellant and copies of the correspondences have enclosed with the W/S.

Heard the Appellant. He has submitted that the information received by him was not in accordance with the information he had sought for. The information he had sought for pertained to the list of appointment(s) to and vacancies in Grade-III and Grade-IV posts in H.P.B. Girls' College during the period of 1<sup>st</sup> August, 2008 to 31<sup>st</sup> December, 2013. He further stated that he has not communicated to the college authorities the shortcomings in the information supplied to him.

In view of the facts brought out above, the Commission hereby orders that the Appellant shall inform the SPIO/Principal, H.P.B. Girls' College, Golaghat in writing the shortcomings/deficiencies in the information already supplied to him. This may be done within a period of 7 days of receipt of this order, on receipt of which the SPIO shall provide the information within a period of 10 days of such receipt, free of cost.

The Appellant shall be at liberty to file a First Appeal to the appropriate First Appellate Authority, if he is aggrieved with the response of the SPIO.

With this, the Appeal petition is disposed of.
