O R D E R

The petitioner Sri Dulal Bora is absent without any information. The public authority is represented by Sri Pradip Handique, Deputy Secretary and PIO of Assam Legislative Assembly Secretariat accompanied by Sri Samir Das, APIO of ALA.

The second appeal petition dated 14-11-2013 is taken up for ex-parte hearing in the absence of the petitioner.

The Deputy Secretary and PIO of ALA has made a written submission dated 19th May, 2016 stating that after receipt of the RTI petition dated 17-5-2013 from the petitioner Sri Dulal Bora, he was asked to deposit Rs. 46 towards the cost of photo copy of the documents sought for by him . On receipt of the required cost, the Joint Secretary and APIO of ALA Secretariat furnished the required information to the petitioner vide letter dated 26th July, 2013.

In his second appeal petition dated 14-11-2013 the petitioner only mentioned that he was not satisfied with the information furnished to him. But he did not indicate which part of the information he was not satisfied with. In his absence in today's hearing, this Commission could not proceed any further in this regard.

The Principal Secretary, ALA and the First Appellate Authority has made a separate written submission dated 19th May, 2016 , wherein it has been mentioned that the first appeal petition of the petitioner was disposed of on 30-7-2013.

In view of the above facts and circumstances of the matter, this Commission disposes of the second appeal petition dated 14-11-2013, with the direction that the SPIO of the Assam Legislative Assembly will allow the petitioner Sri Dulal Bora to inspect the relevant records and documents, if he desires to do so, during office hours , on any working day, within 15 days from the date of receipt of this order and allow the petitioner to take notes and photo copies of any additional documents that the petitioner may require, within the purview of the RTI petition dated 17-5-2013, free of cost up to 20 copies and thereafter on payment of Rs. 2/- for additional page of photo copy.
