## ORDER

The petitioner Sri Dulal Bora is absent without any information. The public authority is represented by Sri Debraj Kalita, SPIO and Town Planner of GMDA.

The second appeal petition dated 17-10-2013 is taken up for ex-parte hearing in the absence of the petitioner.

The SPIO of GMDA submitted that in response to the petitioner Sri Dulal Bora's RTI petition dated 22-7-2013 the petitioner was informed vide their letter dated 2<sup>nd</sup> August, 2013 that the information sought for by the petitioner was not readily available in GMDA's file.

Thereafter, the petitioner filed his first appeal petition dted 29-8-2013 and second appeal petition dated 17-10-2013.

The SPIO of GMDA submitted that in response to his first appeal petition the petitioner was informed by GMDA's letter dated 4<sup>th</sup> September, 2013 that the sought for information cannot be furnished due to insufficient particulars mentioned in the RTI petition.

In view of the above, this Commission directs the SPIO of GMDA to advise the petitioner by Registered Post within 15 days from the date of receipt of this order about the particulars that the GMDA needs from the petitioner, so as to enable them to furnish the required information.

The petitioner is directed to provide the particulars of the information sought for by GMDA within 15 days from the receipt of the request of GMDA and the SPIO is further directed to furnish the sought for information within 15 days from the date of receipt of the particulars from the petitioner.

With the above order the second appeal petition dated 17-10-2013 is disposed

of.
