**O R D E R**

Dr. B.P. Chakravarty, OSD, Directorate of Medical Education, Assam is present. A Written Statement dated 31.05.2016 received from the SPIO, FAA Medical College & Hospital, Barpeta.

The Appellant absent but has sent a Written Statement dated 03.06.2016 through email.

Perused the W/S from the Appellant. She has sent an apology for inability to attend today's hearing on personnel ground. She has also requested to do the needful for furnishing the information she had sought for.

Perused the W/S from the SPIO. It has been submitted that the information sought for had been sent to the Appellant through a letter dated 14.07.2015 after obtaining no objection from the person regarding the information pertaining to his salary statement. Copies of the said letter and enclosures are provided with the W/S. However, no evidence of posting the information has been provided. It is seen that the copy of the W/S has been endorsed to the Appellant.

The Appellant had filed her Second Appeal to the Commission on 21.09.2015 which is in fact after the stated date of furnishing the information by the SPIO. It appears that the information has not reached the Appellant until 04.06.2016 *i.e.* date of the W/S from the Appellant.

It is presumed that the endorsement of the W/S of the SPIO along with its enclosures have been posted to the Appellant and that he would receive in due time.

The OSD in the Directorate of Medical Education, Assam has submitted that he would verify with the SPIO as to whether the enclosures containing the information have been posted, and that if it has not been enclosed, the SPIO would be directed to do the needful so that the Appellant would receive in due time.

With this, the Second Appeal is hereby disposed of.
