**O R D E R**

The SPIO absent without any information.

The Appellant present.

Heard the Appellant. He submitted that he has not received the information he had sought for inspite of his having paid the amount of Rs.678/- towards cost of photocopying as demanded by the SPIO through letter dated 29.07.2015. The Appellant had submitted a photocopy of the bank draft in this regard.

Perused the case record. It is seen from the photocopy of the bank draft that the Appellant had made the bank draft in favour of the Sub-Divisional Agricultural Officer, Barkhetri on 14.08.2015.

In the absence of the SPIO in today's hearing and any Written Statement, it could not be ascertained as to why the information had not been provided inspite of the Appellant having deposited the cost of photocopying.

In view of the facts brought out above, the Commission hereby orders as follows –

1. The SPIO shall provide the information sought for by the Appellant, within 10 days of receipt of this order;
2. The First Appellate Authority/Sub-Divisional Agricultural Officer, Barkhetri shall hear and dispose of the First Appeal dated 12.07.2015, with a speaking order, within 21 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
