The SPIO absent. However, a Written Statement dated 30.05.2016 received from BEEO, Bilasipara.

The Appellant present. Deposing before the Commission, he submitted that he was made to receive the information without seal and signature and therefore, was not satisfied with the response of the SPIO.

Perused the aforementioned W/S along with its enclosure containing the acknowledgment of receipt by the Applicant/Appellant. In his acknowledgment, the Appellant has indeed mentioned that he was not satisfied with the information furnished to him as the same carried no seal and signature. It was the responsibility of the BEEO, Bilasipara to ensure that the documents provided to the Appellant were duly countersigned and authenticated, and should not have given the impression in his submission before the Commission that the information sought for had been duly provided to the Appellant.

In view of the facts brought out above, the Commission hereby orders that the SPIO, office of the BEEO, Bilasipara shall provide the documents relating to the information sought for by the Appellant by duly countersigning and affixing office seal, within 10 days of receipt of this order. The Commission further orders that in order to ensure the compliance with this order, the BEEO, Bilasipara as First Appellate Authority shall consider and dispose of the First Appeal dated 24.06.2014, with a speaking order, within 15 days of receipt of this order.

With this, the Second Appeal Petition is disposed of. .
