The SPIO absent. However, a Written Statement dated 27.05.2016 received with its enclosures from the BEEO, Golakganj which is taken on the case record.

The Appellant present.

Perused the aforementioned W/S. It has been submitted that the information sought for by the Applicant was provided to him through a letter dated 06.07.2014. Thereafter, on receipt of the First Appeal dated 08.05.2014, the DEEO, Dhubri forwarded the same to the Head Teacher of the concerned school through a letter dated 05.07.2014. The Head Teacher supplied the information again on 21.07.2014 to the Applicant directly by registered post. On receipt of the Commission's hearing notice dated 17.05.2016, the Head Teacher has been stated to have written to the Commission dated 25.05.2016 and sent by speed post on 26.05.2016.

Heard the Appellant. He submitted that he had received some information from the Head Teacher of the concerned school only once *i.e.* on 06.07.2014 and has not received the other letters mentioned in the W/S.

From the above, it is thus seen that the Appellant is yet to receive the latest communication of information made to him by speed post on 26.05.2016.

In view of the above, the Commission hereby disposes of the Second Appeal Petition with the direction that the DEEO, Dhubri to whom the First Appeal dated 08.05.2016 had been submitted shall consider and dispose of the same, with a speaking order, within 21 days of receipt of this order.
