**O R D E R**  
25.5.2016

The petitioner Shri Dulal Bora is absent. Nor is any authorized representative as was allowed vide this Commission's order dtd 23.5.16 present. The Public Authority is represented by Mrs. Mayuri Chetia ACS, Deputy Secretary & SPIO of Revenue and Disaster Management Department, Govt. of Assam. The Second Appeal petition dtd 17.10.13 of the petitioner Shri Dulal Bora is taken up for ex-parte hearing.

From perusal of the case records it is seen that the petitioner Shri Dulal Bora vide his RTI application dtd 6.7.13 sought information about the title and use of a plot of land covered by Dag No. 15/958 and Patta No. 210 falling within Chila revenue village under Chila Senduri Ghupa Mouza. The First Appellate Authority as well as the SPIO of Revenue & DM Department have filed two separate written statements both dtd 25.5.16 stating, inter alia, that vide letter dtd 10<sup>th</sup> July, 2013 and 27 September, 2013 the Deputy Commissioner, Kamrup, Amingaon, Guwahati was requested to furnish the sought for information directly to the petitioner. The petitioner in his Second Appeal petition dtd 17.10.13 mentioned that after his First Appeal petition he received the response from the Revenue Department with which he was not satisfied. But in his Second Appeal petition the petitioner did not specify as to which part of the reply of Revenue Department, he was not satisfied with. In his absence in today's hearing it could not be ascertained whether he has

meanwhile received the sought for information from the Deputy commission, Kamrup, Amingaon, Guwahati.

In view of the above, the Deputy Commissioner, Kamrup, Amingaon, Guwahati is directed to furnish the information directly to the petitioner if, not already done, by registered post within 15 days from the date of receipt of this order.

Furnish copy of this order along with the copy of the RTI petition dtd 6.7.13 to the Deputy Commissioner, Kamrup, Amingaon, Guwahati.

With the above order, the Second Appeal petition dtd 17.10.13 is disposed of.
