## <u>ORDER</u>

The petitioner Smti Pankaja Burhagohain is absent without any information. The public authority is represented by :- (1) Sri K. K. Bhagoty, Deputy Director, Office of the Commissionerate of Industries and Commerce, (2) Sri G. C. Rabha, Executive Engineer & 1<sup>st</sup> Appellate Authoririty, (3) Sri Benu Borah, SPIO & Asstt. Industries Officer, of the same office, and (4) Sri Tapan Kr. Ray, Jr. Assistant of the same office.

The second appeal petition dated 15-2-2014 is taken up for hearing ex-parte in the absence of the petitioner.

From perusal of the case records, it is seen that the petitioner filed an RTI petition dated 23-11-2013 seeking 10 different informations relating to procurement of D.G sets by the Directorate of Industries & Commerce, with reference to Tender No. Janasanjyoj/2077/09 dated 19-11-2009. The representatives of Industries & Commerce Department pointed out that the tender No. Janasanjyog/2077/09 is dated 13-11-2009 instead of 19-11-2009.

The representatives of the public authority submitted that they had already furnished the required information to the petitioner vide letters dated 11-2-2014 and again by letter dated 13-3-2014. They have also submitted a Check List before this Commission, stating point-wise 'A' to 'J' of the information furnished to the petitioner. From the check list, it is seen that the information against point No (e), (i) and (j) were not furnished to the petitioner.

In view of the above, this Commission directs the PIO of the Directorate of Industries and Commerce to furnish the information sought for i.e., (e) (i) & (j) by her RTI petition dated 23-11-2013 within 15 days from the date of receipt of this order.

With the above order, the second appeal petition dated 15-2-2014 is disposed of.
