O R D E R

The petitioner Smti Gita Rani Goswami is present along with Sri Sunil Kr. Misra to assist her.

The public authority is represented by (1) Sri Prithviraj Rava, SPIO & Joint Director of Employment and Craftsmen Training (2) Smti Swapna Hazarika, ASPIO & Deputy Director of Employment (3) Sri Raj Kutum, Dealing Assistant (4) Sri Rajib Das, Sr. Asstt.

From perusal of the case records it is seen that the petitioner Smti Gita Rani Goswami vide her RTI petition dated 10-3-2015 raised the following issue :-

Issue : The Directorate of Employment and Craftsmen Training Assam conducted a recruitment written and viva-vocie test for the posts of Junior Assistants (Gr-III) for recruitment under various Heads of Departments, Govt. of Assam. Out of 272 selected candidates, 64 were female candidates. She wanted to know the reason why the recruitment of Women Reservation Quota, i.e. selection of 30% women candidates were not complied with, as is required under the Assam Women (Reservation of Vacancies in Reservation of Posts) Act, 2005.

This Commission is of the view that the petitioner already has the required information, that the Director, Employment & Craftsmen Training appears to have violated the requirement of the above mentioned Act under which 82 female candidates should have been selected, subject to availability of adequate number of eligible candidates, instead of 64 against 272 number of vacancies.

It is now for the petitioner to take further follow-up action in accordance with other relevant law. There appears to be no further cause of action so far as the Commission is concerned.

With the above order, the second appeal petition dated 24-7-2015 is disposed of.
