O R D E R

The petitioner Sri Dulal Bora is absent. The public authority is represented by (1) Sri Rajiv Kr. Jha, Technical Consultant, Assam State Commission for Protection of Child Rights (ASCPCR) and (2) Sri Apurba Das, Supervisor, ASCPCR.

The second appeal petition dated 6-6-2013 is taken up for ex-parte hearing in the absence of the petitioner.

The petitioner Sri Dulal Bora vide his RTI petition dated 11-3-2013 wanted to know from the PIO of the Office of the Chairperson of Assam State Commission for Protection of Child Rights whether any criminally charge-sheeted person is occupying any responsible position in the office.

The officials of ASCPCR submitted before this Commission a copy of their letter dated 11th May, 2016 enclosing a copy of another letter dated 11th April, 2013 from the Administrative Officer of ASCPCR to the petitioner Sri Dulal Bora informing the petitioner that there is no record available in the office of ASCPCR with regard to the information sought for by the RTI petitioner.

But the second appeal petition dated 6-6-2013 filed by Sri Dulal Bora is on the ground of non-receipt of information.

This Commission, therefore, directs the SPIO of ASCPCR to send another copy of their letter dated 11-4-2013 to the petitioner Sri Dulal Bora by Registered A.D post or by Special Messenger within 15 days from the date of receipt of this order.

With the above order, the second appeal petition is disposed of.
