O R D E R

The petitioner Sri Dulal Bora is absent without any information. The public authority is represented by:- Sri Sudhakar Singh, APS, Superintendent of Police (S), S.B (Head Quarters), Kahilipara, Guwahati-19, (2) Sri Upendra Nath Goswami, APS, Deputy Superintendent of Police, Assam Police Headquarters, Ulubari, Guwahati-7, and (3) Sri Paresh Bora, ASI, Assam Police Headquarters, Ulubari, Guwahati.

The second appeal petition dated 27-1-2014 filed on the ground of non-receipt of the sought for information from the DGP, Assam , is taken up for hearing ex-parte in the absence of the petitioner.

From perusal of the RTI petition dated 3-10-2013 filed by Sri Dulal Bora, the petitioner, it is seen that he sought information about the deployment of Personal Security Officers against various protectees .

The Superintendent of Police (SB) Security had informed the petitioner vide letter dated 30-10-2013 that the Special Branch of Police is exempted from the purview of the RTI Act by Govt. Notification No. PLA.384/2005 dated 8-3-2006. Copy is entered into the case records.

The AIGP (Administration) and PIO of the office of DGP, Assam, had also made a written statement dated 27-5-2016 stating that the petitioner's RTI petition dated 3-10-2013 was transferred to the SB Headquarters.

In any case the Special Branch of Assam Police being an exempted organization under the RTI Act, 2005 and the information sought for being a sensitive security matter the second appeal petition dated 27-1-2014 filed by the petitioner Sri Dulal Bora is dismissed.
