The Public Authority is represented by Sri Surjya Baruah, SPIO/CDPO, Debitola ICDS Project, Dhubri.

The Appellant absent.

The First Appellate Authority/District Social Welfare Officer, Dhubri has submitted a Written Statement dated 01.06.2016 which is taken on the case record.

Perused the W/S. It has been submitted that the First Appeal had been forwarded through letters dated 26.05.2014 and 28.02.2014 to the Programme Officer, Divisional ICDS Cell, Kokrajhar stating that the latter was the First Appellate Authority in respect of Dhubri.

Heard the SPIO. He submitted that the information had been provided by the 2 (two) anganwadi centers regarding which the information had been sought. However, no evidence could be provided in this regard.

A perusal of the case record indicates that the Appellant had filed his Second Appeal dated 05.05.2014 by stating that he had not received the information he had sought for. The SPIO submitted that he would be in a position to procure the information and provide the same to the Appellant one more time.

In view of the facts brought out above, the Commission hereby orders that the SPIO/CDPO, Debitola ICDS Project shall procure the information and provide the same to the Appellant, free of cost, within 10 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
