**ORDER**  
20.5.2016

The petitioner Shri Dulal Bora has submitted an application that he will not be able to be present in the hearing due to some urgent work at Court.

The Public Authority is represented by Smt. Dipali Das, Joint Secretary, SPIO, Social Welfare Department, Government of Assam, Dispur, Guwahati-781 006. She has submitted a Written Statement dated 11.5.2016 that the RTI petition of Shri Dulal Bora dated 4.7.2013 was not received by the Department. The petitioner had filed the First Appeal petition dated 29.8.2013 and hearing was taken by the First Appellate Authority on 7.12.2013 and by speaking order dated 19.12.2013 and the then SPIO was directed to furnish the copies of existing guidelines if any, in respect of Anganwadi Workers and Anganwadi helpers, etc., to the petitioner, within 15 days from the date of receipt of the order. The SPIO vide letter dated 18.1.2014 furnished the guidelines in respect of Anganwadi workers and Anganwadi helpers.

On perusal of the notification dated 16.6.2012 furnished to the petitioner, it appears that it relates to procedure of selection of Anganwadi workers and Anganwadi helpers. The petitioner had sought for information on the procedure of the functioning of the Anganwadi workers and Anganwadi helpers. The Commission therefore directs the SPIO, Director, Social Welfare to furnish all the information sought for by the petitioner within 21 days from the date of receipt of this order.

With the above direction, second appeal petition is hereby disposed of.
