Action had been taken by the Deputy PIO Darrang. Shri Prabhat Ch. Saikia, SDAO, Mangaldoi seeking information from the then SDAO Dalgaon/Pathorighat/Mangaldoi, Senior ADO, Shri Dipak Kumar Das and Shri Mahesh Barman (Nodal Officer, Horticulture), alongwith all the ADOs of the District vide their letter dated 20.9.2013.
