The petitioner Sri Mohan Bora is present.

The Public Authority is represented by Sri Tankeswar Chutia, SPIO/Headmaster, Bekajan Girl's High School accompanied by Sri Gauri Sankar Yadav, School Staff.

The SPIO/Headmaster has submitted a written statement dated 06.06.2016 that the information sought for by the petitioner was furnished to him vide letter dated 24.01.2015 by registered post and the same was duly received by the appellant but the appellant had filed another petition on 25.02.2015 that the information received was incomplete.

The petitioner present has submitted a written statement wherein he has complained that the information furnished by the SPIO/Headmaster was false as the Headmaster had mentioned in his reply that Rs. 35,500/- was paid to Graduate Teachers wherein he had received a cheque of only Rs. 32,500/- and to that effect he has enclosed a copy of the cheque received by him amounting Rs. 32, 500/-.

The SPIO/Headmaster present objected to the same and stated that part of the amount was paid in cash due to shortage of cheque books. He produced a copy of the acquaintance roll of the amounts received by the Graduate Teachers and in Serial no. 9, it is seen that the petitioner Sri Mohan Bora had received Rs.35, 500/-. On query whether the signature in the acquaintance roll was of the petitioner, he admitted that it was his signature and also admitted that the amount of Rs.35, 500 was received by him.

In view of the circumstances stated above, the Second Appeal petition dated 23.05.2015 filed by Sri Mohan Bora is found to be without any merit and hence dismissed.
