The Appellant absent but has sent a Written Statement dated 21.06.2016.

Smti. Runu Das, SPIO/CDPO *i/c*, South Golaghat ICDS Project present along with a Written Statement dated 20.06.2016.

Perused the W/S of the Appellant. He has submitted that he has not received any further information after filing of the Second Appeal dated 13.10.2015, and that he had sought for detailed list for beneficiaries.

Perused the W/S of the SPIO. It has been submitted that the information sought for by the Appellant had been furnished to him, free of cost, through a letter dated 22.06.2015 except for contact numbers of the Anganwadi workers/helpers as no telephones had been provided to such workers/helpers by government.

Heard the SPIO. She has explained that as regards beneficiaries list, the numbers of beneficiaries in different age groups and of various categories have been provided. She further added that these numbers vary from time to time, and that the Appellant had not specified any date or period. She also added that giving further details by way of names of the beneficiaries would demand deployment of significant manpower and time leading to diversion of disproportionate volume of resources to furnishing of information under the RTI Act, 2005.

From perusal of the case record, it appears that the Appellant had not specified what more detail he had wanted in the matter of list of beneficiaries, and that the SPIO has provided the information to a reasonable extent.

After a careful consideration, the Commission hereby upholds the views of the SPIO and concludes that there is no more scope for the Appellant to make an Appeal for additional information.

With this, the Appeal Petition is disposed of.
