The SPIO is present along with a Written Statement dated 13.06.2016.

The Appellant absent without information.

Perused the W/S. It has been submitted that the RTI Application had been transferred to the BEEO, Gauripur through a letter dated 28.02.2013, and that no communication has been received from the Applicant as to whether he has received the information he had sought for.

Perused the case record. It is seen that the Appellant had filed the Second Appeal after he failed to receive the information he had sought for and any response from the First Appellate Authority/DEEO, Dhubri.

In the absence of the Appellant or any written submission from him, it could not be ascertained as to whether he has received the information subsequent to filing of the Second Appeal.

In view of the facts brought out above, the Commission hereby orders that the SPIO, office of the BEEO, Gauripur shall procure the information, as available with the Headmaster, Majer Alga Simaltala M.E. Madrassa School, sought for by the Appellant and provide it to him, free of cost, within 10 days of receipt of this order.

As there is no evidence of the First Appellate Authority/DEEO, Dhubri having disposed of the First Appeal dated 02.04.2013, he shall consider and dispose of the same, with a speaking order, within 15 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
