The Public Authority is represented by Sri Dharma Prasad Roy, First Appellate Authority/BEEO, Agomoni along with an assistant and Md. Abul Hossain Ahmed, SPIO/Head Teacher, No. 732 Barbari L.P. School. Written Statements both dated 16.06.2016 received from the FAA and the SPIO respectively.

The Appellant present.

Perused the W/S from the BEEO. It has been submitted that the RTI Application had been transferred to the Head Teacher of the concerned school namely, Barbari L.P. School and an order dated 14.03.2014 was issued by the DMC in disposal of the First Appeal directing the said Head Teacher to provide information within 10 days. It has been added that as reported by the Head Teacher the information sought for was furnished.

Perused the W/S from the Head Teacher. Through the W/S, the action taken to furnish the information and reason for not being able to furnish some of the information has been explained.

Heard the Appellant as well as the Head Teacher. The Head Teacher submitted that some more information can be provided and the reason for not being able to provide the some of the information will be explained to the Appellant.

In view of the facts brought out above, the Commission hereby orders that the Appellant shall visit the office of the Head Teacher, Barbari L.P. School and inspect the documents related to the information sought for and requisition the documents to be photocopied and provide to him, within 7 days of receipt of this order. The SPIO/Head Teacher shall extend all cooperation for this inspection and provide the Applicant upto 20 copies, free of cost. The Applicant shall bear the cost of photocopying documents beyond that number. The entire exercise will be completed within 2 days. The SPIO/Head Teacher shall also provide an explanation to the Appellant in respect of the information that are not available to be provided, within 10 days of receipt of this order.

With this, the Second Appeal is disposed of.
