Sri Soutam Ranjan De, SPIO/Sub-Divisional Engineer, Mankachar Electrical Sub-Division, APDCL, LAR, Mankachar is present along with a Written Statement dated 11.06.2016.

The Appellant present.

Perused the W/S. It has been submitted that the information sought for by the Appellant was furnished through a letter dated 14.10.2014 following the directive of the First Appellate Authority dated 10.10.2014.

Heard the SPIO. He submitted that as the RTI Application had been filed before his joining the post, he was unaware of the same and that he acted promptly on the directive of the First Appellate Authority. He however could not produce any evidence of posting the letter to the Appellant except for the photocopy of the Peon Book through which a copy of the said letter was sent to the SDO (Civil). The latter had acted as the First Appellate Authority.

Perused the case record. It is seen that the Second Appeal had been filed on 06.11.2014. It appears that the Appellant had not received the information at the time of filing the Second Appeal. He however may have received it subsequently.

However, to ensure that the Appellant receives the information he had sought for, the Commission hereby orders that the SPIO shall provide another copy of the information to the Appellant by registered post keeping evidence of the posting thereof, free of cost, within 10 days of receipt of this order.

With this, the Second Appeal is disposed of.
