ORDER 10.06.2016

The petitioner Sri Harinarayan Pathak is present.

The Sr. Administrative Officer & SPIO, SSA, Assam has submitted a written statement dated 09.06.2016 and he has deputed Sri Prasanta Kr Chakrabarty, State Consultant (AS) & ASPIO along with Sri Kandarpa Kr Kalita, SPO (Doc), SSA, Assam to attend the hearing.

On perusal of records, it appears that the petitioner Sri Harinarayan Pathak had filed an RTI petition dated 18.09.2014 before the SPIO, office of the Mission Director, SSA, Kahilipara, Assam. The petitioner on 01.11.2014 had filed his First Appeal petition addressed to the Mission Director, SSA, Kahilipara, Assam due to non receipt of information. On 26.12.2014, he filed the Second Appeal petition before the Commission.

On careful perusal of record, it appears that the First Appeal filed by the petitioner before the Mission Director, SSA, Kahilipara, Assam on 01.11.2014 had not been disposed of. The Appeal petition dated 01.11.2014 is therefore remanded to the Mission Director, SSA, Kahilipara, Assam for disposal with a speaking order after hearing the petitioner, within 30 days from the date of receipt of this order.

With the above direction, the Second Appeal Petition dated 26.12.2014 is disposed of. The petitioner will be at liberty to move the Commission with Second Appeal or Complaint petition, if he is not satisfied with the decision of the First Appellate Authority.
