<u>O R D E R</u> 14.06.2016

The petitioner Sri Indra Rongphar is absent. He has submitted a written statement dated 11.06.2016 informing that he had not received the information from the SPIO, office of the Deputy Director, P & RD (Hills), Karbi Anglong against his RTI petition dated 13.09.2013.

The SPIO is absent. He has submitted a written statement dated 10.06.2016 that he has deputed Sri Dondoram Phangcho, Superintendent, O/o the Deputy Director, P & RD (Hills), Karbi Anglong to attend the hearing. The SPIO has failed to appear without any reasonable cause and is directed to be careful in future.

On perusal of records, it appears that the petitioner vide his RTI petition dated 13.09.2013 addressed to the SPIO, Office of the Principal Secretary, KAAC, Diphu had sought for information on the list schemes under State Plan and HADP. The same was transferred to the Deputy Director, P & RD, Hills, Karbi Anglong on 18.09.2013. He filed the First Appeal on 13.11.2013 before the Deputy Director, P & RD, Hills, Karbi Anglong and Second Appeal on 04.01.2014 before the Commission.

The Superintendent present has submitted photocopies of the 6 sanctioned letters sought for by the petitioner Sri Indra Rongphar. The Commission directs the SPIO, Deputy Director, P & RD, Hills, Karbi Anglong to furnish the information to the petitioner within 1 week from the date of receipt of this order.

With the above direction, the Second Appeal petition dated 04.01.2014 is disposed of.
