The petitioner Sri Indra Rongphar is present.

The Public Authority is absent without any information.

In view of large number of cases pending before the Commission, the instant matter is taken up for hearing *ex parte*.

On perusal of records, it appears that the RTI petition is filed by Sri Indra Rongphar on 02.12.2015 addressed to the SPIO, office of the Mission Director, RMSA, Kahilipara. The petition was transferred to the SPIO, Principal Secretary, KAAC with a request to furnish the information directly to the petitioner. The Principal Secretary, KAAC transferred the RTI application to the District Programme Co-ordinator, RMSA, Karbi Anglong on 04.02.2016. Due to non receipt of information, the petitioner filed the First Appeal on 23.02.2016 before the District Mission Co-ordinator, Karbi Anglong and Second Appeal on 19.04.2016 before the Commission.

The Public Authority has failed to appear today without any intimation. On careful perusal, it appears that the First Appeal filed by the petitioner before the District Mission Co-ordinator, Karbi Anglong on 23.02.2016 had not been disposed of. The Appeal petition dated 23.02.2016 is therefore remanded to the District Mission Co-ordinator, Karbi Anglong for disposal with a speaking order after hearing the petitioner, within 15 days from the date of receipt of this order.

With the above direction, the Second Appeal petition dated 19.04.2016 is disposed of.
