The petitioner Sri Harinarayan Pathak is present.

The Public Authority is represented by Smti. Mayuri Chetia, ACS, Deputy Secretary & SPIO, Revenue and Disaster Management Department.

The SPIO submitted a written statement dated 10.06.2016 stating that information could not be provided to the petitioner Sri Harinarayan Pathak as no land patta or allotment letter for land was made by the Hon'ble Chief Minister. The official function dated 24.02.2014 referred to by the appellant was in connection with the distribution of land settlement order as per official procedure. Accordingly, the appellant was informed by the then SPIO vide letter no. RSS.262/2014/18 dated 03.04.2014. Thereafter, the petitioner filed the First Appeal dated 09.04.2014 addressed to the Commissioner & Secretary to the Govt. of Assam, Revenue and Disaster Management Department and the First Appellate Authority vide order dated 07.05.2014 heard that the reply furnished by the SPIO was in order and First Appeal petition has been rejected as found without merit worth appeal.

On careful perusal of relevant documents, it appears that information furnished by the SPIO and the order of the First Appellate Authority date 07.05.2014 was in order.

In view of the above, the Second Appeal petition dated 14.07.2014 is dismissed.

A copy of each of the written statement submitted by the SPIO and order of the First Appellate Authority dated 07.05.2014 may be provided to the petitioner as prayed for by him under section 7 (4) of the RTI Act, 2005.
