**O R D E R**  
20.06.2016

Sri Lalit Ch. Konwar, SPIO/A.E.E. (T/C) P.W.D., Barpeta Rural Road Division is present. Written Statements, both dated 18.06.2016, received from the First Appellate Authority/Executive Engineer, PWD, Barpeta Rural Road Division and the SPIO respectively.

The Appellant is present along with a Written Statement dated 19.06.2016.

Perused the W/S from the SPIO and FAA. The SPIO has submitted that the part of the Application relating to Sl. No. f, g & i had been transferred to the SPIO, office of the Chief Engineer, P.W.D. (Roads) through a letter dated 22.07.2015 and information relating to the rest were provided through a letter dated 18.08.2015 after receiving the deposit of cost of photocopying. The FAA has submitted that the First Appeal had been heard and a direction issued to the SPIO to provide the information/documents which were stated to have been wanting in the information provided. As regards the documents which were not authenticated, it has been submitted that the Appellant had been requested to present these documents in the office so they can be certified. It has also been submitted that the documents had been provided as available in the office and that therefore, it was not true that the information provided was incomplete or misleading or fake as alleged.

Heard the Appellant. He submitted that he was still waiting for the information from the SPIO, office of the Chief Engineer, PWD (Roads) the transferred items. In his W/S, he has listed the deficiencies in the information supplied to him. He also submitted that a copy of the W/S has been submitted to both the SPIOs.

In view of the facts brought out above, the Commission hereby orders as follows –

1. The SPIO, office of the Chief Engineer, P.W.D. (Roads) shall certify the copies of the newspaper cuttings on NIT and the copy of C.S. already provided to the Appellant. To enable this, the Appellant shall send copies of the said paper cuttings and copy of C.S. to the SPIO by registered post, within 7 days of receipt of this order, and that the SPIO shall return the same to the Appellant by registered post after having the documents certified by their concerned official, within 7 days of receipt of such communication;
2. The SPIO, office of the Executive Engineer, Barpeta Rural Road Division shall respond to the issues raised by the Appellant as mentioned above, and explain if any information sought for was not available to be provided, within 10 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
