O R D E R

The petitioner Sri Saroj Kr. Saraf is absent without any information. The public authority is represented by :- (1) Sri Surjya Kanta Bora, Secretary, AUWSSB, Guwahati, (2) Sri Munindra Kumar Deka, Asstt. Engineer, and (3) Sri Arup Jyoti Das, L.D. Asstt of the same office.

The complaint petition dated 21-1-2014 is taken up for hearing ex-parte in the absence of the petitioner.

From perusal of the case records, it is seen that vide his RTI petition dated 17-10-2013 filed before the PIO of the office of Managing Director, Assam Urban Water Supply and Sewerage Board (AUWSSB), the petitioner Sri Saroj Kr. Saraf sought informations regarding the payment already made and outstanding payments payable to him by AUWSSB in respect of 2 (two) supply orders in his favour.

In his petition dated 21-01-2014, which was erroneously registered as a complaint petition, he petitioner made an appeal before this Commission to look into the matter and do the needful so that the required informations are furnished to him at an early date.

In view of this his application dated 21-01-2014 is taken up as a second appeal petition for consideration.

The representatives of the public authority , who were present today, deposed that they had already furnished the required information to the petitioner vide letters dated 18-6-2014 and 17-11-2014 respectively in response to the information sought for by the petitioner vide his RTI petition dated 17-10-2013

However, from perusal of the communication made by the AUWSSB, it is seen that the information furnished to the petitioner is not very clear. This Commission, therefore, directs the PIO of AUWSSB to furnish clear information to the petitioner mentioning the total amount admissible for payment to the petitioner, amount already paid to him and balance outstanding remaining to be paid to him as on the date of his RTI petition dated 17-10-2013.

The PIO of AUWSSB is further directed to furnish this information within 15 days from the date of receipt of this order..

With the above order, the second appeal petition dated 21-1-2014 is disposed of.
