**O R D E R**

5.7.2016

The petitioner Smti. Gauri Maya Dey is absent without any information. The public authority is represented by :- (1) Smti. Esther Kathar, Addl. Deputy Commissioner, Land Revenue (Land Sale), Kamrup (M), and (2) Smti. Jyotsna Medhi Patgiri, ADC and SPIO, Kamrup (M). The second appeal petition dtd 20.3.14 is taken up for hearing ex-parte in pursuance of this Commission's earlier order dtd 22.6.16.

From perusal of the case records it is seen that vide her RTI petition dtd 5.9.13 the petitioner wanted copies of sale deed, Jamabandi, sketch map, etc., in connection with the sale permission No. KPM.2/2002/766 dtd 10.10.02. It is also seen that the Deputy Commissioner, Kamrup (M) in his capacity as First Appellate Authority had directed ADC Land Revenue (Land Sale Permission) to furnish the required information to the appellant within one month from the date of receipt of the order. The FAA's order was dtd 12.12.13. The ADC, Land Revenue (Land Sale permission) Smti. Esther Kathar submitted that the information could not be furnished as the relevant records could not be traced out.

This Commission observes that recurrence of missing records relating to land revenue matters under Deputy Commissioner, Kamrup (M) seem to be becoming frequent. This Commission directs the Deputy Commissioner, Kamrup (M) to cause an inquiry into this case of missing records and report the outcome to this Commission within 30 days from the date of receipt of this order.
