**O R D E R**

The Public Authority is represented by Salma Ahmed Hussain, Director, A.M.D.B. along with her assistants. She has submitted a Written Statement dated 23.06.2016.

The Complainant/Appellant present.

Perused the W/S. It has been submitted that in compliance with the order of the Commission dated 18.04.2016, a copy of the document each already provided to one of the Applicants has been dispatched to the Complainant by speed post on 02.05.2016.

Perused the case record. It is seen that the Complainant Md. Nabab Ali had acknowledged the receipt of the documents. However, he was not satisfied stating that it was incomplete and the information furnished were not in accordance with the RTI Application. He has requested for facilitating furnishing of the information.

It is seen from the Complaint letter dated 16.05.2016 that the Complainant has not explained in detail as to why he considers the information incomplete and have no relation to the Application. The Commission therefore hereby orders that in case the Complainant is still interested in the information, he will communicate to the SPIO, the details of the discrepancies he has found in the information supplied to him through the letter dated 29.04.2016, within 7 days of receipt of this order. Within 15 days of receipt of such communication, the SPIO shall provide the wanting information to the Complaint/Appellant, free of cost.

In view of the above, the Complaint about non-compliance of the Commission's order dated 18.04.2016 is hereby disposed of.
