The Complainant/Appellant present.

The SPIO/Secretary, No.10, Dakshin Bahjani Gaon Panchayat, Nalbari is absent.

Perused the case record. It is seen that the Complainant/Appellant filed a Complaint dated 30.05.2016 submitting that the information provided to him by the Secretary of the aforementioned GP in compliance with the order of the Commission dated 21.04.2016 was not in accordance with the approved plan and estimate of the work, and that a copy of the sanction of the amount of Rs.1,40,000/- has not been provided.

Heard the Complainant/Appellant. He submitted that the information that was provided was not in accordance with the approval/sanction of the work therefore, he requires certified copies of the approved estimate of the works and their sanction by the competent authority.

In the absence of the SPIO/Secretary of the GP, the Commission did not have the benefit of his response to the issues raised by the Complainant/Appellant.

In view of the facts brought out above, the Commission hereby orders that Secretary, No. 10, Dakshin Bahjani Gaon Panchayat shall carefully examine the Complaint letter submitted to the Commission by the Complainant/Appellant, Md. Makshed Ali dated 30.05.2016, a copy of which was forwarded with the Commission's hearing notice no. SIC/NLB.3/2015/47 dated 16.06.2016, and provide him certified copies of the documents sought for by the Appellant/Complainant namely, copies of the project report and estimate, and of the sanction order to the Appellant, free of cost, within 10 days of receipt of this order.

With this, the Complaint case is disposed of.
