O R D E R 02.07.2016

The Appellant present.

The SPIO absent. He has not submitted any Written Statement on the status of furnishing of information which was sought for by the Commission through its hearing notice dated 16.06.2016. He has also not explained as to why penalty shall not be imposed on him/her under Section 20 (1) of the RTI Act, 2005 for his/her failure to furnish the information to the Applicant within the stipulated period of 30 days.

The First Appellate Authority/PD, DRDA, Nagaon has not apprised the Commission about the steps he may have taken to dispose of the First Appeal dated 27.11.2014 which he was asked to do through its aforementioned hearing notice.

Heard the Appellant. He submitted that he had filed his Second Appeal dated Nill after he failed to receive the information from the office of the BDO, Kathiatoli Development Block. He also complained about rough treatment he received from the officials in the BDO's office.

Perused the case record. The Appellant's Second Appeal pertains to the information he had sought for from Kathiatoli Anchalik Panchayat through two Applications on the same date *i.e.* 29.09.2014, and the information sought for relating to list of beneficiaries of IAY and detailed information relating to fund spent under DDP, TFC, MGNREGA etc. in Kathiatoli Anchalik Panchayat.

From the records available in the Commission and submission by the Appellant, it appears that the SPIO, office of the BDO, Kathiatoli Development Block and the BDO of the Block have not discharged their duty and responsibility enjoined on them by the RTI Act, 2005.

Considering the facts of the case, the Commission hereby orders as follows -

- 1. The SPIO, office of BDO, Kathiatoli Development Block, Nagaon shall furnish the information sought for by the Appellant, free of cost, within 15 days of receipt of this order;
- 2. The SPIO, office of BDO, Kathiatoli Development Block, Nagaon shall submit a written explanation to the Commission, within 15 days of receipt of this order, as to why penalty shall not be imposed on him/her under Section 20 (1) of the Act for his/her failure to furnish the information to the Applicant within the stipulated period of 30 days.

Should the SPIO fail to provide the information in compliance with this order within the time stipulated, the Appellant shall be at liberty to file fresh First Appeal with the appropriate First Appellate Authorities in respect of IAY and other schemes.
