ORDER

The petitioner Shr S.U. Pachani is absent without information. The Public Authority is represented by Smti. Mayuri Chetia, ACS, Deputy Secretary and SPIO of Revenue and Disaster Management Department, Govt. of Assam. The complaint/ Second Appeal petition dtd 20.8.13 filed by Shri S.U. Pachani is taken up for consideration ex-parte in his absence.

The Deputy Secretary & SPIO of Revenue & DM Deptt. has made a written submission dtd 10.6.2016 stating that the copy of the Government order No. RSS.1467/2006/4 dtd 6.12.2006 was furnished to the petitioner vide letter dtd 6.7.2013 in response to his RTI petition dtd 21.6.13, i.e. within the stipulated 30 days time limit. The petitioner's complaint petition dtd 20.8.13 is based on the ground that he had not received certified copy of the above mentioned Government order. Since the Public Authority had furnished the information within the stipulated time, the ground for the complaint does not appear to be tenable. However, to conclusively redress the complaint of non-receipt of the information already furnished, this Commission directs the SPIO of Revenue & Disaster Management Department, Govt. of Assam to send attested copy of the above mentioned order to the petitioner once again by registered post within 15 days from the date of receipt of this order.

With the above order, the complaint petition dtd 20.8.13 is disposed of.
