**O R D E R**

The petitioner Shri Pradip Kr. Das is absent without information. The Public Authority is represented by (1) Shri Pranab Kumar Choudhury, Executive Engineer, PWD, Udalguri Rural Road Division, Udalguri, and (2) Shri Khagendra Sarmah, Dy. Accounts Officer, Udalguri Rural Road Division. The Second Appeal petition dtd 5.2.14 is taken up for hearing ex-parte in absence of the petitioner.

From perusal of the case records it is seen that the petitioner Shri Pradip Kr. Das filed an RTI petition dtd 21.11.13 before the SPIO of the office of the Executive Engineer, PWD, Udalguri Rural Road Division. From the RTI petition it is seen that earlier one Shri Tapan Das sought information from the same Public Authority regarding construction of road from Ojahgaon to Kalaigaon including cross drainage work and routine maintenance of the work for five years under PMGSY, Phase VII, package No. AS-26-22. Shri Tapan Das was furnished information by the concerned PWD authority. The present petitioner Shri Pradip Kr. Das wanted certified copies of the same information which was furnished to Shri Tapan Das.

The representative of the Public Authority present today deposed that they have already furnished the sought for information to Shri P.K. Das vide their letter dtd 4.4.16.

In view of the above and in absence of the petitioner, this Commission does not see any further cause of action and accordingly the second Appeal petition dtd 5.2.14 is disposed of.
