The Public Authority is represented by Sri Swapan Kumar Das, Sub-Divisional Engineer, Jagiroad Electrical Sub-Division, APDCL, Jagiroad and Sri Pramod Chandra Das, Jr. Manager, Jagiroad Electrical Sub-Division, APDCL, Jagiroad. Written Statements dated 27.06.2016 and 28.06.2016 have been received from the Assistant General Manager, APDCL, Morigaon Division and the SPIO/S.D.E., Jagiroad Electrical Sub-Division respectively.

Perused the case record. The Appellant had filed his Second Appeal dated 28.03.2014 after he failed to receive the information he had sought for through his Application dated 13.07.2013.

Perused the W/S from the SPIO. It has been submitted that the information had been provided to the Appellant through a letter dated 24.02.2014 and once again through a letter dated 20.10.2014. On learning that he had not received the information, the same information along with additional information was provided one more time through a letter dated 03.06.2016 by registered post. Copies of the letters are enclosed with the W/S along with a photocopy of the postal receipt as proof of dispatch of the third letter.

Perused the W/S from the Morigaon Division. It has been submitted that the Jagiroad Electrical Sub-Division now comes under the jurisdiction of the newly created Jagiroad Electrical Division. The fact of furnishing of the information to the Appellant has been confirmed by the W/S.

In view of the facts brought out above, the Second Appeal Petition is hereby disposed of.
