**O R D E R**

The Complainant/Appellant present.

The SPIO/Secretary, No.10, Dakshin Bahjani Gaon Panchayat, Nalbari is absent.

Perused the case record. It is seen that the Complainant/Appellant has filed a Complaint dated 30.05.2016 of non-compliance by the SPIO with the order of the Commission dated 21.04.2016. He has submitted that the documents supplied to him contain anomalies such as overwriting in hand, and illegible ID numbers in the list of IAY beneficiaries. According to him, the list of IAY beneficiaries supplied to him after the Commission's hearing differs from the list of IAY beneficiaries that had been supplied to him after the First Appeal. The order of the Commission dated 21.04.2016 was that the SPIO, office of the BDO, Pub-Nalbari Development Block shall, with the help of Secretary of the GP, reconcile the anomalies between the statement/list supplied to the Appellant and provide a reconciled statement of IAY beneficiaries duly certified. Neither the SPIO, office of the BDO nor the GP Secretary is present in today's hearing to represent their case.

In view of the facts brought out above, the Commission hereby reiterates its orders that the SPIO, office of the BDO, Pub-Nalbari Development Block shall, with the help of Secretary of the GP, reconcile the anomalies between the statement/list supplied to the Complainant/Appellant and provide a reconciled statement of IAY beneficiaries duly certified, free of cost, within a period of 10 days of receipt of this order.

With this, the Complaint case is disposed of.
