## ORDER

21.6.2016

The petitioner Shri Monmohan Sarma is present. He is accompanied by his brother Shri S.K. Misra. The Public Authority is represented by (1) Shri P. Rava, JDE & SPIO o/o Directorate of Employment & Craftsmen Training, Assam, (2) Smti. S. Hazarika, DDE & ASPIO, o/o DE&CT, Assam, (3) Shri Raju Kutum, Jr. Administrative Asstt, and (4) Shri Rajib Das, Sr. Asstt of the said office. The Second Appeal petition dtd 27.10.15 is taken up for hearing in presence of both the parties.

The Director incharge & SPIO of the Directorate of Employment & Craftsmen Training (E&CT) submitted a written statement dtd. 20.6.16, which was entered into the case records.

From perusal of the case records it is seen that the petitioner filed an RTI petition dtd 10.6.15 before the SPIO of the Directorate of E&CT, Govt. of Assam.

The information sought for by him were:-

- The marks scored by the selected candidates (144 Nos) in the viva voice test which was held by the Selection Committee of the Directorate of E&CT against Grade IV posts under the different Heads of Departments, Govt. of Assam, and
- 2. The number of Gr. IV posts that were lying vacant under the Directorate of E&CT. The SPIO and Jt. Director of the Directorate informed the petitioner vide letter dtd 13.8.15 that the matter was already decided by the Hon'ble High court. The Jt. Director & SPIO of DE&CT furnished the copy of the

Hon'ble High Court's order to the petitioner along with his letter dtd 13.8.15.

From perusal of the Hon'ble High Court's order, copy of which has been furnished to the petitioner, it is seen that the information sought for by the petitioner, i.e. marks scored by the 144 nos of candidates selected in the viva voice test is not mentioned in the High Court's order.

This Commission is of the view that the information sought for by the petitioner vide his RTI petition dtd 6.10.15 is admissible under the RTI Act. This Commission directs the Jt. Director & SPIO of the Directorate of Employment & Craftsmen Training to furnish the sought for information to the petitioner within 15 days from the date of receipt of this order.

With the above order, the Second Appeal petition dtd 27.10.15 is disposed of.
