The petitioner Sri Dulal Bora is absent without any information. The public authority is represented by:- (1) Sri Dipak Kr. Barman, Executive Engineer , Guwahati Building Divn-II and 1<sup>st</sup> Appellate Authority, and (2) Sri Madhusudhan Das, Asstt. Executive Engineer (T.C) PIO of the same office.

The second appeal petition dated 27-1-2014 is taken up for hearing ex-parte in the absence of the petitioner with reference to RTI petition dated 18-3-2013 by which he sought informations about a work order No. KDP(M)/NRHM/Stabilization Unit/6/2009/41 dated 18-6-2013

The Executive Engineer, Guwahati Building Division-II has made a written submission dated 28-6-2016 which is entered into the case records. He has stated that vide letter dated 2-4-2013 (copy enclosed with the written statement), part of the information was furnished to the petitioner. By the same letter, the petitioner was asked to deposit Rs. 212/- towards the cost of photo copying the documents sought for by him. The petitioner did not deposit the said amount and hence the documents were not furnished to him.
