O R D E R

The petitioner Sri Dulal Bora is absent without any information. The public authority is represented by:- (1) Sri Dipak Kr. Barman, Executive Engineer , Guwahati Building Divn-II and 1st Appellate Authority, and (2) Sri Madhusudhan Das, Asstt. Executive Engineer (T.C) PIO of the same office.

The second appeal petition dated 27-1-2014 is taken up for hearing ex-parte in the absence of the petitioner.

The Executive Engineer, Guwahati Building Division-II has made a written submission dated 28-6-2016 regarding action taken by his office on the RTI petition dated 18-2-2013 relating to this appeal case. The written statement is entered into the case records.

From perusal of the case records, it is seen that vide his RTI petition dated 18-3-2013 the petitioner wanted information about an work order No. NRHM/C-CCO/New PHC/ 543/08/P-I/5573 dated 5-7-2008. The Executive Engineer present submitted that this information is available with the Superintending Engineer (Planning) in the office of the Chief Engineer, PWD (Building), Chandmari, Guwahati. Accordingly , vide letter dated 22-3-2013 the RTI petition was transferred to the Superintending Engineer with a request to furnish the information to the petitioner.

From the appeal petition dated 21-9-2013 and the second appeal petition dated 27-1-2014, it seems that some information was furnished to the petitioner , but he was not satisfied with it. But the petitioner has not mentioned why or which part of the information received by him he was not satisfied with. In the absence of the petitioner it could not be ascertained.

This Commission, therefore, directs the Superintending Engineer (Planning), Chandmari, Guwahati-3 to allow the petitioner to inspect the relevant records and documents , during Office hours, on any working day, within 15 days from the date of receipt of this order and also allow him to take notes and photo copies of records and documents

sought for by him up to 20 copies and thereafter on payment of Rs. 2/- for every additional page of photo copy.

With the above order, the second appeal petition dated 27-1-2014 is disposed of
