## ORDER

The petitioner Shri Dulal Bora is absent. The public authority is represented by:- (1) Shri Aswini Kumar Bhattacharyya, ASPIO & Under Secretary, Environment & Forests (E&F) Deptt., Govt. of Assam, and (2) Shri Prabodh Haloi, Sr. Admin. Assistant of E& F Department. The second appeal petition dtd 4.3.14 is taken up for hearing ex-parte in absence of the petitioner.

The ASPIO and Under Secretary of E&F Department produced before this Commission a copy of letter dtd 6.11.13 transferring the RTI petition dtd 28.10.13 submitted by Shri Dulal Bora to the SPIO of the office of the Principal Chief conservator of Forests (PCCF), Assam, Rehabari, Guwahati. In absence of the petitioner it could not be ascertained whether he has meanwhile received the requried information from the SPIO of the PCCF, Assam. If not, this Commission directs the SPIO of the office of the PCCF, Assam to allow the petitioner to inspect the relevant records and documents during office hours on any working day within 15 days from the date of receipt of this order and also allow him to take notes and photocopies of required documents free of cost up to 25 copies and thereafter on payment of Rs. 2.00 for every additional page of photocopy.

With the above order, the second appeal petition dtd 4.3.14 is disposed of.
