**O R D E R**  
18.07.2016

The Appellant present.

The Public Authority is represented by Smti. Swapna Hazarika, Dy Director of Employment with an assistant and Sri Joy Prakash Rajioun, SPIO/Superintendent *i/c.*, ITI Dhansiri. A Written Statement dated 15.07.2016 received from the SPIO which is taken on the record.

Perused the W/S. In the W/S, the action taken for providing the information sought for through the RTI Application dated 25.07.2015 has been detailed. It has also been submitted that after receiving the order of the FAA dated 27.01.2016 and in compliance thereof, both hard and soft copies of the information had been provided to the Applicant through letter dated 05.02.2016. A copy of the letter dated 15.07.2016 written by the First Appellate Authority to the SPIO and endorsed to the Commission has been received and taken on record. Through the said letter, it has been submitted that the First Appeal had been heard and an order issued on 19.10.2015. A copy of the said order is enclosed with the letter.

Heard the Complainant. He submitted that he has received the information relating to the first two points in his RTI Application and he was yet to receive the information relating to third point. He further submitted that regarding the third point he had received a letter from the Superintendent, ITI Dhansiri on 05.01.2015 stating that the information could not be provided as it involved third parties. The Complainant reiterated that he had received the information on the first two points only and not on the third point.

As the Complainant was still interested in getting the information, he requested that his Complaint case may be treated as an Appeal.

In his response, the SPIO submitted that he would now provide the soft copies of the information relating to the third point as directed by the FAA/Director, Employment & Craftsmen Training, Assam.

Perusal of the case record indicates that the information on the third point related to mark- sheet of candidates pertaining to qualifying academic examination.

In view of the facts brought out above, the Commission hereby orders that the SPIO/Superintendent, ITI Dhansiri shall provide a soft copy of the information sought for by the Appellant as the third point of his Application namely “photocopies of the qualifying examination mark-sheet of all candidates as per clause 1 & 2 above”, free of cost, within 10 days of receipt of this order.

With this, the Appeal Petition is disposed of.
