Neither representative submitted a Written Statement. The Appellant's representative submitted that the Appellant has not received any further information after he filed the Second Appeal Petition dated 24.08.2015 with the Commission. The SPIO's representative submitted that it has taken them time to locate all the records relating to the information sought for owing to the relevant works dating back to 1998-1999, and that they would now be able to provide the information in a few days time.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall provide the full information with reference to the RTI Application, First Appeal and Second Appeal of the Appellant as sought for, free of cost, within 10 days of receipt of this order.

As it has been alleged by the Appellant that he received no response from the First Appellate Authority/D.C., Golaghat to his First Appeal dated 11.06.2015 and there is no evidence to the contrary, the FAA/D.C., Golaghat shall consider and dispose of the said First Appeal, with a speaking order, within 15 days of receipt of this order in accordance with the RTI Act, 2005.

The Commission hereby draws the attention of the D.C., Golaghat to the fact that the SPIO in his/her office/establishment has not complied with the provisions of the Act in the matter of furnishing information sought for by the Applicant/Appellant.

With this, the Second Appeal Petition is disposed of.
