Shri Jitendra Nath Bora, BDO, Golaghat North Block is present.

The Complainant/Appellant is absent without information. He has submitted his Complaint/Appeal dated 26.10.2015 and 25.04.2016 to the Commission under Section 18 (1) of the RTI Act, 2005. As he has prayed for facilitating furnishing of the information that he had sought for, his Petition is being treated as an Appeal case.

Heard the BDO. He has submitted that the information was provided to the Appellant through a letter dated 22.08.2015. A copy of the said letter was submitted to the Commission by the Appellant.

Perused the case record. It is seen that through the aforementioned letter the SPIO, office of the BDO, Golaghat North Block had informed the Appellant that no work had been done in the said village in Madhya Brahmaputra Gaon Panchayat and sought the name of the specific scheme to enable furnishing of the information. In his reminder letter dated 10.09.2015 the Appellant had given further description of the work on which he had sought the information. The BDO submitted that he had not received the copy of the said letter. A copy of the letter has been made in the Commission and handed over to him in the course of the hearing.

The BDO admitted personally that the First Appeal dated 03.09.2015 had not been disposed of. He further submitted that he is now in a position to provide the information available in his office about the work mentioned above by the Appellant.

Considering the facts brought out above, the Commission hereby orders as follows -

- 1. The SPIO, office of the BDO, Golaghat North Block shall provide the information sought for by the Appellant, free of cost, within 10 days of receipt of this order; and
- 2. The First Appellate Authority/BDO, Golaghat North Block shall consider and dispose of the First Appeal dated 03.09.2015, within 15 days of receipt of this order.

With this, the Appeal case is disposed of.
