The petitioner Sri Harinarayan Pathak is present.

The Public Authority is represented by Sri Ghana Pegu, SPIO & i/c Addl. R.C.S, Assam assisted by Rakesh Hazarika, Dealing Assistant.

The SPIO has submitted a written statement dated 04.07.2016 that they had furnished all 4 (four) nos. of information sought for by the petitioner except point no.1 (c) vide letter dated 15.05.2014 received from Addl. Registrar of Co-operative Societies. It was stated that the information as desired in point no. 1 (c) was not available in Audit Branch.

The petitioner present stated that he has not received any information issued vide letter dated 15.05.2014. He also stated that the letter from the Reserve Bank of India (RBI) as mentioned at Sl. 1 (c) of his RTI petition dated 03.05.2011 is available in the office of the Registrar of Co-operative Societies, Khanapara.

The SPIO present stated that letter mentioned at 1 (c) was not received by the office. He however requested the petitioner to visit his office and collect the copy of the reply already furnished to him vide letter dated 15.05.2014 and also to furnish a copy of the RBI's letter dated 03.05.2011, if available with the petitioner for taking necessary action which was agreed to by the petitioner.

In view of the above, the Commission directs the petitioner to visit the office of the Registrar of Co-operative Societies, Khanapara and collect the copies of the documents furnished to him earlier within 7 days from the date of receipt of this order. He will also furnish a copy of the RBI's letter dated 03.05.2011 which is stated to be available with him to the SPIO during his visit to the office of the Registrar of Co-operative Societies, Khanapara. Thereafter, the SPIO, office of the Registrar of Co-operative Societies, Khanapara will furnish the information on action taken, if any to the petitioner within 15 days from the date of receipt of this order.
