The Principal Secretary, KAAC has submitted a written statement dated 11.07.2016 that he has deputed Sri Dipanjit Baruah, Liaison Officer, KAAC, Diphu to attend the hearing.

The Addl. Director, Soil Conservation (Hills), Karbi Anglong has submitted a written statement dated 11.07.2016 that the information relating to Hamren Division was furnished to the applicant vide letter dated 17.10.2014 but the petitioner present stated that he had not received any such information. However, the information on Hamren Division has been furnished by the SPIO to the petitioner today during the hearing.
