ORDER 27.06.2016

The petitioner Sri Indra Rongphar is present.

The Public Authority is absent without any information.

In view of large number of cases pending before the Commission, the matter is taken up for hearing *ex parte*.

On perusal of records, it appears that the petitioner Sri Indra Rongphar had filed an RTI petition dated 23.09.2015 before the SPIO, office of the KAAC who in turn transferred the same to the Addl. Chief Engineer, Irrigation, Zone-IV, Karbi Anglong on 13.10.2015. The petitioner on 13.11.2015 filed the First Appeal before the Addl. Chief Engineer, Irrigation, Zone-IV. The Addl. Chief Engineer, Irrigation vide letter dated 10.12.2015 transferred the First Appeal petition to all the Executive Engineer under Zone-IV, Irrigation, Diphu to furnish the information to the petitioner directly. On 23.02.2016, the petitioner filed a Complaint petition before the Commission for non-receipt of information.

In view of the above, the Commission directs the SPIO, office of the Addl. Chief Engineer, Irrigation, Zone-IV/Executive Engineer under Zone-IV to furnish the information to the petitioner within 15 days from the date of receipt of this order.

With the above direction, the petition dated 23.02.2016 stands disposed.
