The petitioner Sri Indra Rongphar is present.

The Public Authority is represented by Sri Dipanjit Baruah, Liaison Officer on behalf of Karbi Anglong Autonomous Council (KAAC).

The Principal Secretary, i/c KAAC has submitted a written statement dated 18.06.2016 informing that the Watershed Development Project in shifting cultivation areas (WDPSCA) scheme in Karbi Anglong had already been winded up in 2012 and the post of Project Officer, WDPSCA (SPIO) no longer exists. He also informed that some documents had already been furnished to the petitioner earlier and some documents have been submitted on 20.06.2016.

The Principal Secretary, KAAC has also submitted a written statement dated 21.06.2016 that due to shifting of files from the old secretariat building to the present building some records, files etc. of WDPSCA scheme have been misplaced, as such for tracing out the remaining documents further time may be given.

In view of the facts stated above, the Commission directs the SPIO, Office of the Principal Secretary, KAAC to furnish the information as sought for by the petitioner within 30 days from the date of receipt of this order.
