O R D E R

The petitioner Sri A. K. Laskar is absent without any information. The public authority is represented by:-1) Sri Sanjib Kr. Phukan, Asstt. Academic Officer and SPIO of the Director of Madrasa Education, Assam, Kahilipara, Guwahati- 19, and (2) Sri Khagen Ch. Kalita, Stenographer, Office of the Director of Madrasa Education, Assam, of the same office.

The second appeal petition dated 4-6-2014 is taken up for hearing ex-parte in the absence of the petitioner.

From perusal of the case records, it is seen that the petitioner filed an RTI petition dated 14-3-2014 before the SPIO of the office of the Secretary, Secondary Education Department, Govt. of Assam, seeking information against 13 different points about appointment of one Md. Fazlur Rahman as the In-charge Director, Madrasa Education, Assam.

It is seen that the RTI application was transferred by a letter dated 5th April, 2014 by the Deputy Secretary, Secondary Education Department to the Director of Madrasa Education, Govt. of Assam for furnishing the required information directly to the petitioner.

Vide letter dated 2nd May, 2014 the SPIO of the Director of Madrasa Education, Assam, requested the petitioner Sri A. K. Laskar to collect the information from the Directorate stating that the information sought for by the petitioner is ready. The SPIO of the Directorate of Madrasa Education has made a written submission dated 22nd June, 2014, enclosing a letter dated 30-5-2014 from the petitioner, which mentions that he has received a few of the informations sought for. The SPIO has also mentioned in the written statement that although the RTI petition dated 14-3-2014 was transferred by the Secretary, Education Department to the Director, Madrasa Education, the remaining sought for informations like :- (a) Education Department's note sheet dealing with the appointment of Md. Fazlur Rahman as In-charge Director of Madrasa Education, (b) his appointment order, (c) copy of his joining report, and (d) copies of any administrative provision for attachment of the services of an Assistant Professor as Deputy Director, Madrasa Education, Assam, are not maintained in

the Directorate of Madrasa Education. The Govt. in the Secondary Education Department is the holder of such informations.

This Commission, therefore, directs the SPIO of the Secondary Education Department, Govt. of Assam, to furnish the above mentioned informations to the petitioner within 15 days from the date of receipt of this order.

With the above order, the second appeal petition dated 4-6-2014 is disposed of.
